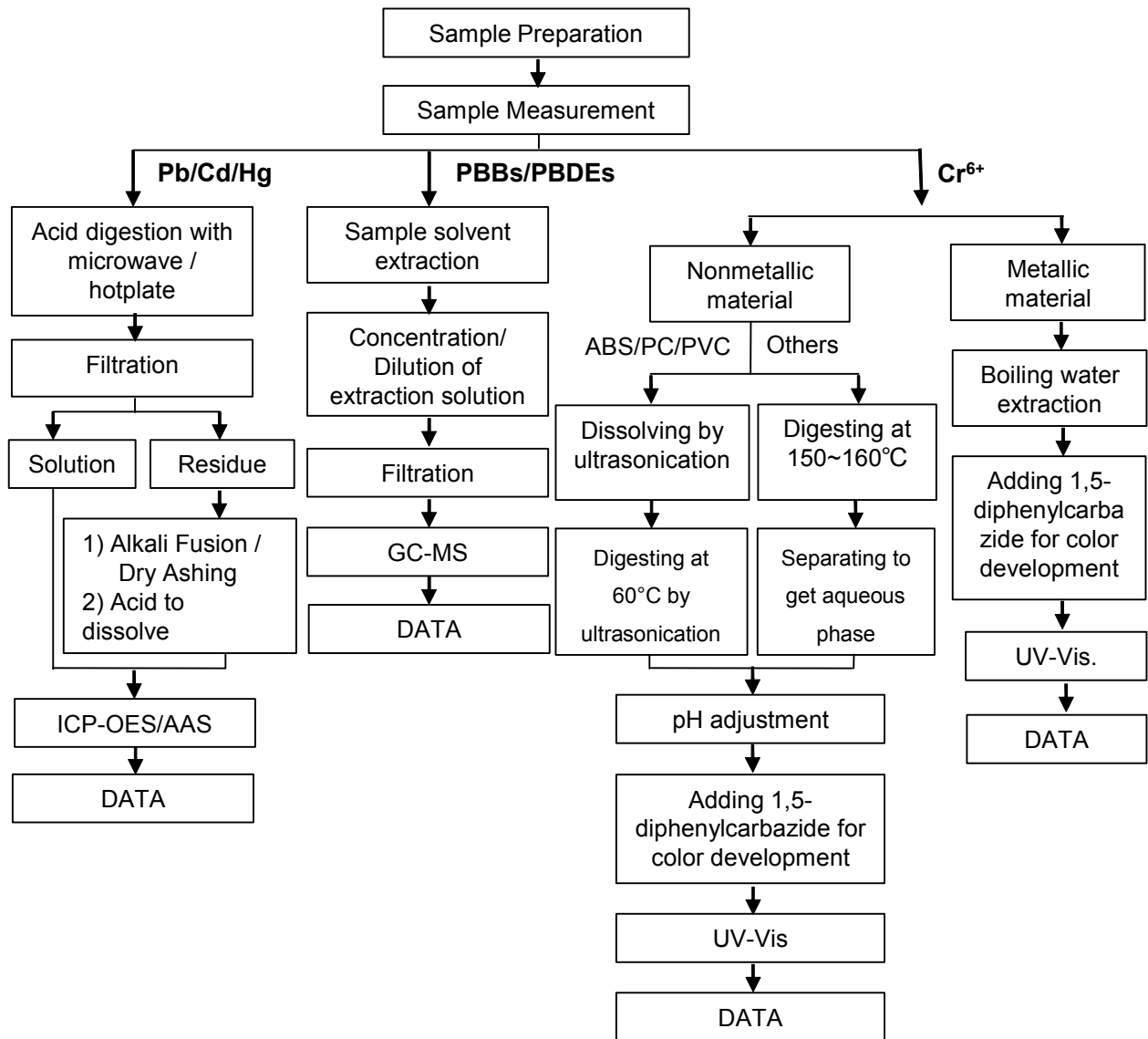

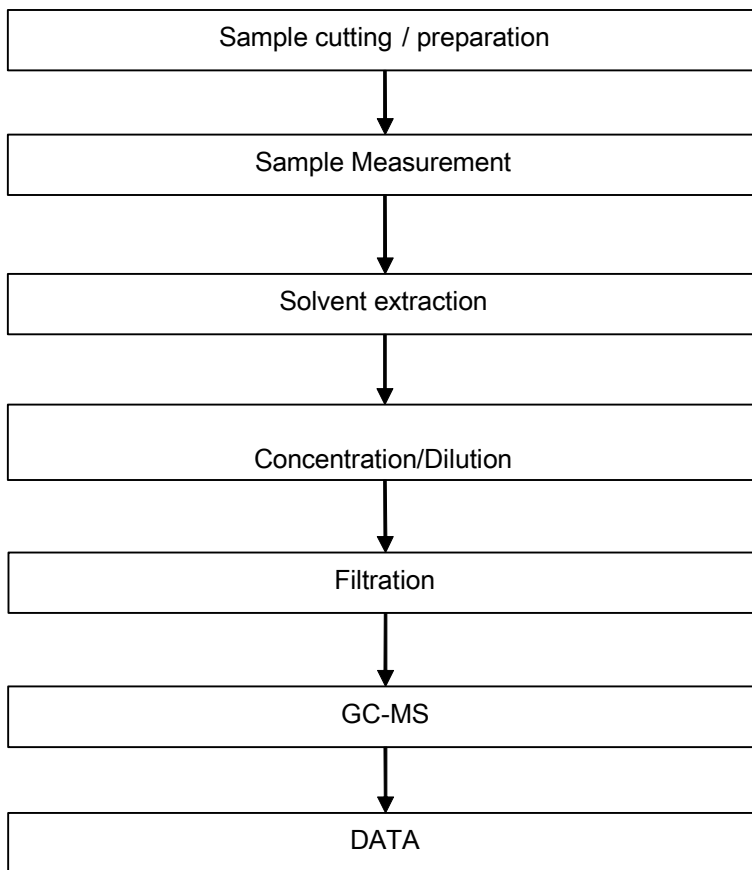

Phthalates Testing Flow Chart

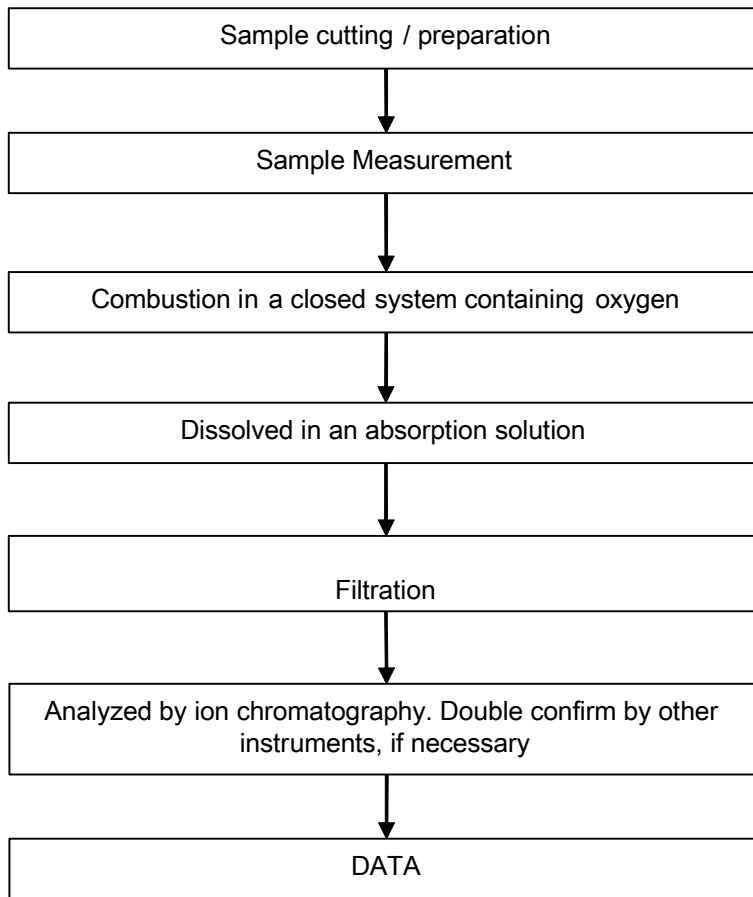

Halogen Testing Flow Chart

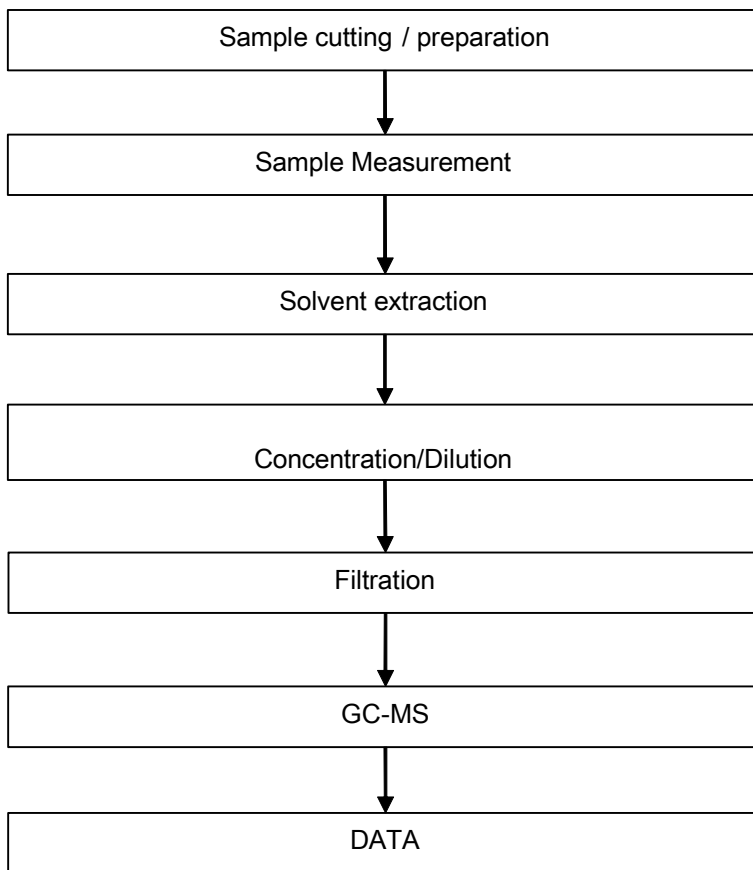

PAHs Testing Flow Chart

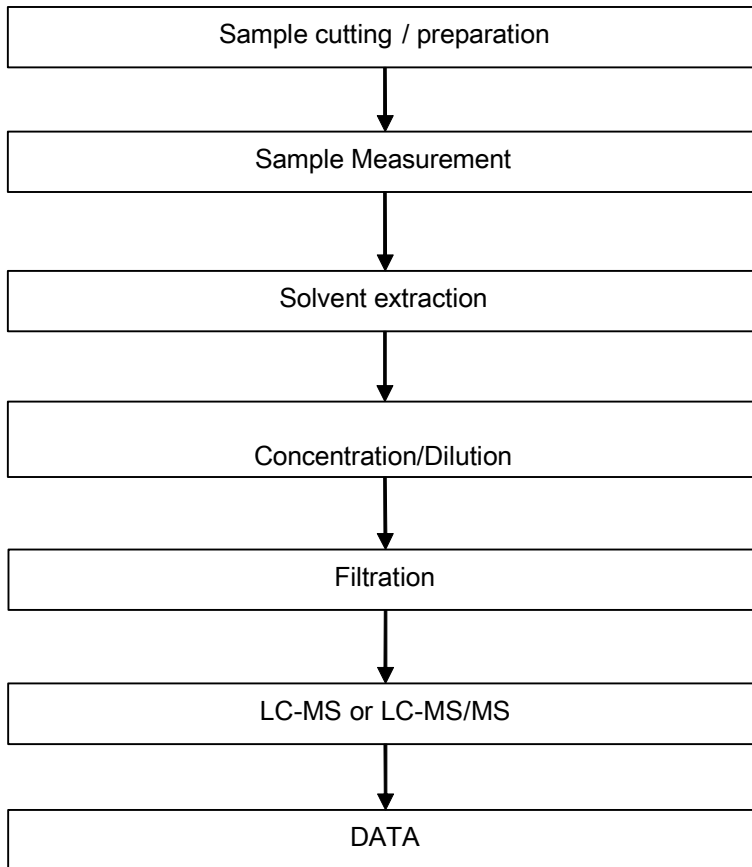

PFOA / PFOS Testing Flow Chart

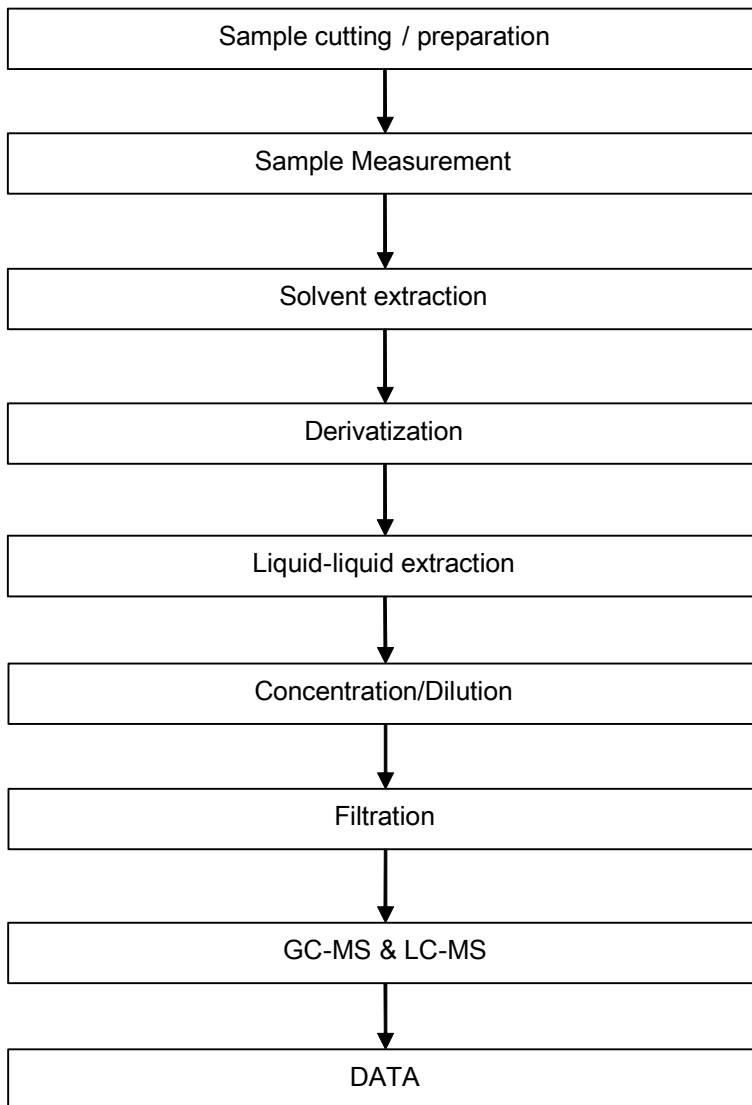
